



## RELEASE AND WAIVER OF LIABILITY

Releasor, being of lawful age (or, in the case of a minor, though his/her parent or guardian), in consideration of being permitted to participate in the Brazilian Soccer Academy NJ soccer program/event hosted by Brazilian Soccer Academy NJ, hereby releases and discharges Brazilian Soccer Academy NJ from all present and future liabilities, debts, obligations, costs, expenses, damages, losses, charges, judgements, executions, liens, claims, demands actions or causes of actions of whatever nature or descriptions, in equity or at law, which the Releasor or his/her child or ward family, state, heirs, representatives, executors, administrators, successors or assigns (collectively, "Related Parties") may have, whether known or unknown, suspected or unsuspected, asserted or not asserted, arising out of participation by Releasor or his/her child or ward in the Even.

The Releasor understands, acknowledges and accepts that this Release and Waiver is intended to binding on the Releasor and Releasor's Parties. The Releasor further understand, acknowledge and accepts that participation in the soccer program/event involves certain inherent risks, including, but not limited to, property damage and serious bodily injury (including death), and agrees that the Releasor or his/her child or ward is voluntarily participating in the soccer program/event with full knowledge of the risks involves and accepts all risks of participation.
